### Capital Campaign/Fundraising (Wendy)

Fundraising:

Late on annual fall campaign. Email and snail mail solicitations with SASEs will go out shortly Capital Campaign: needs resuscitation. Needs a chair. Brochure needs updating to be short, to the point and convincing.

Phase 1 completed and paid for, we have approximately \$280,000 budgeted for continuing work on phase 2. Do work on phase 2 in two sections: 2A: Children's area, 2B: storage area. Kevin: Marist has a course on communications devoted to getting money for non-profits. He thinks he can have the students work for us. They have done good work in the past. There is also a student group which might be able to help us.

For the campaign for 2A, put in an estimated budget with a 25% cushion: if we don't use it all for 2A it will still be needed for 2B. It is important to replenish the Vanguard Fund.

Wendy will set up a meeting of the Capital Campaign after the Finance Committee Meeting.

Mary: hanging signs needed for stacks. She has approached the Rotary

Anne: In the spread sheet from capital project report, Friends gift for the window shades was put in as part of the operating budget rather than as part of the capital campaign. Doesn't really matter as long as things balance out.
